This Privacy Policy explains how Tuumo Oy (“we”, “us”, or “our”) collects, uses, and discloses your information when you use our services, and your rights regarding your personal data. By using our services, you agree to the practices described in this Privacy Policy.

Interpretation and Definitions

Interpretation

Capitalized terms in this Privacy Policy have specific meanings defined below. These definitions apply whether the terms are singular or plural.

Definitions

- **Account:** A unique account created for you to access our Service.
- **Affiliate:** An entity that controls, is controlled by, or is under common control with a party.
- **Company:** Refers to Tuumo Oy, located at Samoilijantie 3 A 1, 70200 Kuopio, (“we”, “us”, “our”).
- **Cookies:** Small files placed on your device that store information about your browsing activity.
- **Country:** Refers to Finland.
- **Device:** Any device that can access the Service (computer, mobile, tablet, etc.).
- **Personal Data:** Any information that identifies or can identify an individual.
- **Service:** Refers to app.tuumo.fi.
- **Service Provider:** Third parties or individuals who process data on behalf of the Company.
- **Usage Data:** Data collected automatically from the Service or its infrastructure.
- **Website:** Refers to app.tuumo.fi.
- **You:** The individual or entity accessing or using the Service.

Collecting and Using Your Personal Data

Types of Data Collected

Personal Data

We may collect personally identifiable information such as:

- Email address
- Account information
- Other data you provide voluntarily

Usage Data

Collected automatically, including:

- IP address, browser type and version
- Pages visited, time spent, device identifiers
- Mobile device information when accessing via phone or tablet

Tracking Technologies and Cookies

We use cookies, web beacons, and similar technologies to monitor activity and improve our Service.

- **Session Cookies:** Deleted when you close your browser; essential for service functionality.
- **Persistent Cookies:** Remain on your device; used for remembering preferences and settings.
- **Functionality Cookies:** Remember your choices to enhance user experience.

How We Use Your Personal Data

We may use your information to:

- Provide and maintain the Service
- Manage your Account
- Perform contracts and transactions
- Communicate important updates
- Offer news, promotions, and information about similar products/services
- Handle requests or inquiries
- Conduct business transfers (mergers, acquisitions, asset sales)
- Analyze usage trends and improve the Service

Sharing Your Information

We may share your data with:

- Service Providers
- Affiliates
- Business partners
- Other users when you interact publicly
- With your consent
- In connection with business transactions

Retention of Your Personal Data

We retain personal data only as long as necessary for the purposes outlined in this Privacy Policy or to comply with legal obligations.

Usage data may be kept for a shorter period unless required for security or legal reasons.

Transfer of Your Personal Data

Your data may be transferred to and stored in locations outside your country. By using our Service, you consent to this transfer. We implement reasonable safeguards to protect your data during transfers.

Deleting Your Personal Data

You may request deletion of your personal data by:

- Accessing your account settings
- Contacting us directly

We may retain certain information when legally required.

Disclosure of Your Personal Data

We may disclose your data in situations including:

- Business transactions (merger, sale, acquisition)
- Legal obligations (law enforcement requests, compliance)
- Protecting rights, property, or public safety

Security of Your Personal Data

While we strive to protect your data using commercially acceptable methods, no transmission or storage system is 100% secure.

Children’s Privacy

Our Service does not knowingly collect personal information from children under 13. If discovered, we take steps to remove the data.
