Interpretation and Definitions

Interpretation

Words with the first letter capitalized have meanings defined below. The definitions apply whether singular or plural.

Definitions

For the purposes of these Terms and Conditions:

- Application means the software program provided by the Company, accessible at app.tuumo.fi, used on any electronic device.
- Application Store means the digital distribution service operated by Apple Inc. (Apple App Store) or Google Inc. (Google Play Store) from which the Application may be downloaded.
- Affiliate means an entity that controls, is controlled by, or is under common control with a party, where "control" means ownership of 50% or more of voting rights.
- Country refers to Finland.
